

1.1 POLICY OVERVIEW

At Media Inventions, we're committed to protecting and respecting your privacy.

This Policy explains when and why we collect personal information about people who visit our website, how we use it, the conditions under which we may disclose it to others and how we keep it secure.

1.2 WHO ARE WE?

Media Inventions is a registered company (no. 04453639). The registered address is Media House, 63 Victoria Road, TROWBRIDGE BA1 7LD.

1.3 HOW DO WE COLLECT INFORMATION FROM YOU?

We obtain information about you when use our website and/or through discussions with our staff if you contact us about our services.

1.4 WHAT TYPE OF INFORMATION IS COLLECTED FROM YOU?

The personal information we collect might include your name, address, email address, IP address, and information regarding what pages are accessed and when.

1.5 HOW IS YOUR INFORMATION USED?

We may use your information to carry out our obligations arising from any contracts entered into by you and us, to deal with enquiries and questions, to seek your views or comments on the services we provide, to notify you of changes to our services, and to process a job application. We do not maintain a mailing list, and hold personal data in order to fulfil current, past and future contracts.

We review our retention periods for personal information on a regular basis. We are legally required to hold some types of information to fulfil our statutory obligations (for example for HMRC etc). We will hold your personal information on our systems for as long as is necessary for the relevant activity, or as long as is set out in any relevant contract you hold with us.

1.6 WHO HAS ACCESS TO YOUR INFORMATION?

We will not sell or rent your information to third parties.

Third Party Service Providers working on our behalf: We may pass your information to our third party service providers, agents, subcontractors and other associated organisations for the purposes of completing tasks and providing services to you on our behalf. When we use third party service providers, we disclose only the personal information that is necessary to deliver the service or we are required to do so by law.

We will not share your personal information with third parties for marketing purposes.

We may transfer your personal information to a third party as part of a sale of some or all of our business and assets to any third party or as part of any business restructuring or reorganisation, or if we're under a duty to disclose or share your personal data in order to comply with any legal obligation or to enforce or apply our terms of use or to protect the rights, property or safety of our customers. However, we will take steps with the aim of ensuring that your privacy rights continue to be protected.

1.7 YOUR CHOICES

We will not contact you for marketing purposes by email, phone or text message unless you have given your prior consent. We will not contact you for marketing purposes by post if you have indicated that you do not wish to be contacted. 1.8 HOW YOU CAN ACCESS AND UPDATE YOUR INFORMATION

1.9 HOW WE PROTECT AGAINST THE LOSS, MISUSE OR UNAUTHORISED ALTERATION OF YOUR INFORMATION

When you give us personal information, we take steps to ensure that it's treated securely. We don't store any credit or debit card details and we protect all other details where possible.

Non-sensitive details (your email address etc.) are transmitted normally over the Internet, and this can never be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, we cannot guarantee the security of any information you transmit to us, and you do so at your own risk. Once we receive your information, we make reasonable effort to ensure its security on our systems. Where we have given (or where you have chosen) a password which enables you to access certain parts of our websites, you are responsible for keeping this password confidential. We ask you not to share your password with anyone.

1.10 USE OF 'COOKIES'

Like many other websites, the Media Inventions website uses cookies. 'Cookies' are small pieces of information sent by an organisation to your computer and stored on your hard drive to allow that website to recognise you when you visit. They collect statistical data about your browsing actions and patterns and do not identify you as an individual.

1.11 LINKS TO OTHER WEBSITES
